YOUR JOB SITE COORDINATORS ARE VOLUNTEERS WITH BUSY SCHEDULES OF THEIR OWN. THIS COMBINED WITH THE POSSIBLE NEED FOR SPECIAL ORDERING MATERIALS NECESSITATES THAT THESE DEADLINES BE HONORED TO ENSURE MATERIALS ARE AT YOUR SITE MONDAY MORNING.
2. WE DO NOT SUPPLY ANY FORM OF CAMPING EQUIPMENT.
3. **NO PETS ARE ALLOWED.** TEMPERATURES ARE TOO HOT FOR PETS TO BE KEPT IN TRAILERS OR VEHICLES AT HARMISON WHILE YOU ARE AT YOUR WORK SITE.
